RESOLUTION NO. 13-26

WHEREAS, the North East Regional Mobility Authority ("NET RMA") was created pursuant to the request of Gregg and Smith Counties and in accordance with provisions of the Transportation Code and the petition and approval process established in 43 Tex. Admin. Code § 26.1, et seq. (the "RMA Rules"); and

WHEREAS, the Board of Directors of the NET RMA has been constituted in accordance with the Transportation Code and the RMA Rules; and

WHEREAS, subsequent to the initial formation of the NET RMA the Counties of Cherokee, Rusk, Harrison, Upshur, Bowie, Cass, Panola, Van Zandt, Wood, and Titus joined the Authority and are represented on the Board of Directors; and

WHEREAS, the NET RMA is pursuing the eventual development of the proposed East Texas Hourglass, an extension of Toll 49, in Smith, Gregg, Upshur, and Harrison Counties; and

WHEREAS, the proposed East Texas Hourglass includes Segment 7 of Toll 49; and

WHEREAS, on March 26, 2013, the NET RMA Board of Directors approved the selection of RS&H to serve as one of the general engineering consultants ("GEC") to the NET RMA and authorized the Chairman to execute an agreement with RS&H for the provision of general consulting civil engineering services; and

WHEREAS, the GEC has developed a proposed scope of services for environmental services for Segment 7 of Toll 49; and

WHEREAS, a copy of that proposed scope of services is contained in the work authorization attached hereto as Attachment "A" ("Work Authorization No. 2"); and

WHEREAS, the GEC has represented to the Board of Directors that the work reflected in Work Authorization No. 2 is necessary and appropriate.

NOW THEREFORE, BE IT RESOLVED, that the Board of Directors approves Work Authorization No. 2 in the form attached hereto as <u>Attachment "A"</u>; and

BE IT FURTHER RESOLVED, that all work performed under Work Authorization No. 2 shall be subject to the Agreement for General Consulting Civil Engineering Services between the NET RMA and the GEC and that no additional work may be undertaken without the specific approval of the Board of Directors.
