CALL TO ORDER AND DECLARATION OF QUORUM.

Notice of this meeting was posted with the Secretary of State's Office and on the NET RMA website and office on Friday, July 12, 2024.

Gary Halbrooks - We're going to go ahead and get started. Number one, call to order and declaration of quorum. Second Judge AJ Mason from Cass County is here.

Judge AJ Mason - This is my opportunity to say welcome to Camp County. Camp County is one of new counties or relatively new counties, and the Camp is the third smallest county in the state. We've got 12 whole miles of US 271 out front here in our county. Being a new county, we're so pleased that you're here today. So, I want to say if you haven't had the opportunity yet, the Efurd family that owns all this, they're about third generation peach growers here in Camp County next door. If you've never been over to the peach shed, I encourage you to go take advantage of that. Action Item

Glenn Green – This is a project that I have briefed the board on. It is moving quickly, and this is the project that we started on helping with some of the engineering, but there was still a gap in the construction plans. They need help widening the road on the project. This is a project with multiple entities. What is before you today is a resolution authorizing the executive director to execute the funding agreement. Questions?

Scott Martinez – Thank you for having me today. Just to give some background, we are funded differently than other EDCs. We are funded by our members. One thing I noticed quickly in this position is that this area did not have an industrial park in the area. We see this as a regional employment center due to its position. We are seeing a lot of demand for this project. We just had an offer this morning. Overall, it is a been a group project.

Gary Halbrooks - What is the number of jobs?

Scott Martinez – YellowWood will offer about 125 jobs. We will make sure the NET RMA will get their money back.

Glenn Green – (Video is played) As a result, staff recommends approval.

Dave Spurrier – Who will oversee the signal?

Glenn Green – We would be, and we would be paid back.

A. Roadway Maintenance Activities

Glenn Green – First item, with all the rain we continue to experience erosion. I want to bring this to the board's attention because we will have to increase our budget for the next budget year. This is not a big deal, just wanted to make you aware. Next summer, we are preparing for a heavy overlay on a section of toll 49. We have been setting funds aside since last year. I just wanted to make you aware. Also, I wanted to let you know we have had a significant request for access to the right of ways. These are becoming more and more active, and I wanted to prepare you if you are approached. They can cause a lot of problems. With the help of Lochner, we have updated our utility policy.

B. Utility Permitting Process

Glenn Green - Last item, this project was presented to the priority projects committee. Right here, you have no turn lanes to enter Efurd orchards. This project has been an issue since I was in the Atlanta district. Only reason I am bringing it up today is because we are right here.

Matthew watts – Is this an example of a priority project?

Glenn Green – Yes, we would help complete the project once the majority of the funds are accumulated.
