#### 7. REVIEW AND ACCEPTANCE OF NET RMA FINANCIAL STATEMENTS.

#### 8. COMPREHENSIVE REPORT ON TOLL 49 TOLLING TRANSACTIONS AND REVENUE.

Justin Winn – I am here to do an update on trends on Toll 49 including usage. The first slide shows GDP growth. The NETRMA area is comparable with the national and state level. Similar to unemployment, Smith County is right out or below the state level. Since 2014 you can see the increased traffic over time. Traffic is just slightly down. It is probably impact with weather. You can see that Toll 49 tracks with National usage. Looking at the gantries specifically, the main volume amount is along the western area. The highest is Prairie Creek mainline. If we look at trucks, it has been similar. The biggest truck volumes are at prairie creek but decreases as you get closer to southern Tyler.

Dave Spurrier – I realize about 8% is truck usage, but what is the amount of the revenue

Guest – It is about 25 and 30%

Dave Spurrier – Going forward, I would love a breakdown of this in the future since it is such a large amount of our revenue.

Discussion ensued between CDM Smith and Dave Spurrier

Justin Winn – As we look at the ABI in detail, you can see the long growth trend. We have seen a decrease in March and April, and we will be investing this further. We believe the true ABI share is higher, but it takes time to accumulate that data. On an daily scale, you can really see how the weather affects the amount of travel on the road. Finally, you can see how transactions match projections. When looking at 2022 and 2023, these are slightly below. This is the same with 2024. One thing I would note, the revenue is matching the projections, but the number of vehicles is lower.

### 9. UPDATE ON MARKETING AND COMMUNICATIONS PROGRAM.

David Gibbs – My colleague, Katie, and we will be going over the presentation. First, we will give over the Linda Thomas Scholarship. The scholarship spreads awareness for safe driving. The applications have been increasing every year and this is our 4<sup>th</sup> year. Also, we had 11 of the 14 counties participate. The winners were selected by the board based on the application, GPA and extracurricular activities. We also saw a lot of variety for future degrees. We are about to play a video to go a little more in depth for the scholarship.

#### VIDEO PLAYED

We used that video on the website, but obviously on local media. We were able to secure 8 spots in local media. Questions?

Robert Messer – We have been giving \$1,000 for a long time. Do we need to look at increasing the amount since \$1,000 used to be.

David Gibbs – This is a valid question and think we should talk about it for the future.

Katie – We can compare this in the industry and see what everyone is doing.

Gary Halbrooks – Let's kick this to Andrea and her committee. They can talk about this.

Katie – Our previous advertising campaign won an award and wanted to thank you for your support. This campaigned with someone driving and a clone next to them. They were a good side and a bad side. We did a second campaign with this that will be live in August. Questions? April is national distracted driving month. Ted once again let our community know how to drive safely. We advertised in multiple ways. We had 166 clicks, 2.8M impressions, and 82% viewership. Next year we might consider a different series, but we will see.
