

**GENERAL MEETING OF THE BOARD OF DIRECTORS  
OF THE NORTH EAST TEXAS  
REGIONAL MOBILITY AUTHORITY**

**RESOLUTION NO. 11-04**

WHEREAS, the North East Texas Regional Mobility Authority (“NET RMA”) was created pursuant to the request of Gregg and Smith Counties and in accordance with provisions of the Transportation Code and the petition and approval process established in 43 Tex. Admin. Code § 26.1, *et seq.* (the “RMA Rules”); and

WHEREAS, the Board of Directors of the NET RMA has been constituted in accordance with the Transportation Code and the RMA Rules; and

WHEREAS, subsequent to the initial formation of the NET RMA the Counties of Cherokee, Rusk, Harrison, Upshur, Bowie, Cass, Panola, Titus, Van Zandt, and Wood joined the Authority and are represented on the Board of Directors; and

WHEREAS, the NET RMA identified the proposed Toll 49 project (“Toll 49”) as its initial project in the petition filed under the RMA Rules; and

WHEREAS, on June 14, 2007, the Texas Transportation Commission (the “Commission”) approved Minute Order Number 110964 in which it identified a list of candidate projects, including the proposed Toll 49 project (“Toll 49”), for development, construction, and operation as toll projects and directed TxDOT staff to work with local toll project entities to develop market valuations for those projects; and

WHEREAS, TxDOT’s Tyler District and the NET RMA agreed on business terms and conditions for the Toll 49 market valuation as required by Section 228.0111 of the Texas Transportation Code, and, in Resolution No. 08-08, dated April 16, 2008, the NET RMA Board of Directors approved the business terms and conditions for the market valuation analysis for Toll 49; and

WHEREAS, in Resolution No. 08-12, dated June 18, 2008, the NET RMA exercised its option to be the entity to develop Toll 49; and

WHEREAS, the NET RMA identified Segment 3B of Toll 49 (the “Toll 49 Segment 3B Project”) as a project it intends to develop through a design/build comprehensive development agreement (“CDA”); and

WHEREAS, in Resolution No. 10-12, dated October 20, 2010, the Board of Directors approved entry into a design/build CDA for the development of the Toll 49 Segment 3B Project with CH2M HILL Constructors, Inc. and, contingent upon the attorney general’s determination that the CDA is legally sufficient, authorized the Chairman to execute the design/build CDA; and


WHEREAS, the NET RMA has designated a Project Director to assist the NET RMA with administering and managing NET RMA projects; and

WHEREAS, the Board of Directors desires to authorize the NET RMA Project Director to act as its designee to prosecute the construction of the Toll 49 Segment 3B Project and to authorize necessary actions and expenditures in connection with the development and operation of Toll 49, provided that the scope of such actions and expenditures has been previously approved by the Board of Directors.


NOW THEREFORE, BE IT RESOLVED, that the NET RMA Project Director is hereby authorized to take such actions as may be necessary to prosecute the construction of the Toll 49 Segment 3B Project and to authorize necessary actions and expenditures in connection with the development and operation of Toll 49 on behalf of the NET RMA, provided that the scope of such actions and expenditures has been previously approved by the Board of Directors.
